




Student Pharmacist

Bill Haas talked about what it means to be a father, and what fathers and grandfathers teach. He said today's fathers need to not let [external] things get in the way of culture and family. He talked about what fathers do for families: they let children know they are loved, are positive role models, raise a child's self-esteem, lower the risk of juvenile delinquency, and teach life skills.

Haas said the average father spends eight minutes a day with their kids. "Let's pave the way to do better than that, let's make a commitment to be the dads we can be; teach our kids honor and respect," he said.

Its farmers market Voucher time!

Who is eligible?

- Shawano County Residents
- Age 60 or above, or Native American age 55 years or above
- Has a monthly **household income of \$1815 or less** for one person and **\$2456 for two people** (which would be 185% of the federal poverty guideline)

How does the program work?

- Enrolled seniors will receive vouchers worth **\$25 per household**. The voucher can only be used to purchase locally grown fresh produce at approved farmers markets or roadside stands.
- Shawano County has a list to provide you with approved farmers markets and stands.
- The vouchers expire October 31st, 2015

How do I get a vouchers if I can't come to the distribution site?

- If you are home bound, or unable to get to a distribution site due to a disability, you can send a signed statement with an authorized representative that you designate stating that they are there on your behalf to apply for the certification, or request a standard proxy from the Shawano County Aging Unit. Your representative may be required to provide proof of your age and your income.

Our dear old Dad, Matthew Powless, 80, went to be with his ancestors Saturday, June 20, 2015 at home surrounded by his family following a brief illness. He was born January 17, 1935 in Tigerton Wisconsin, the son of the late Peter and Marcella (Sickles) Powless. He was a Member of the Oneida Nation and longtime resident of the Stockbridge-Munsee Reservation near Bowler, WI. He had a humble beginning on the Central Wisconsin cranberry bogs where his mother and father worked. At age 12 he learned to drive and drove himself to school, work on the farm, and to the woods where he worked as a lumberjack.

After graduating from Tigerton High School in 1953 he entered the United States Army where he served proudly as a paratrooper in the 82nd Airborne at Fort Bragg, NC. Following his service in the U.S. Army, he returned home to work in the logging industry and

later in the Trades Industry where he traveled the United States and became skilled as a carpenter, pipefitter, and welder. He later joined the Millwright Union 2158 (Elgin, ILL.) and 1056 in Wisconsin where he later taught many young people the art of welding. Dad not only took pride in his work, but he enjoyed sports and was an accomplished fighter not only in life but in the boxing ring as well. He also loved to dance at the casino and at pow-wows; he was a champion smoke dancer.

Homelands Update: Site Monitoring



Working with New York State Museum Cultural Resource Survey Program and New York State Department of Transportation on a project site in Albany

With the warmer weather, archeological season has begun. Many projects are happening right now across our Hudson River Valley homelands where test pits are being dug to see if there is a cultural site in the line of project construction.

Our Historic Preservation Committee and Tribal Council have provided guidance that we should work to leave cultural materials intact whenever possible and, as a last resort, remove them for reburial (as in the case of human remains) or curation by the tribe (such as tools and other artifacts).

For site monitoring, ideally we work closely with the archeologist early on in process to review their plans for how they will test.

For example, we might request changes to how close they plan to dig test pits in certain areas, or the techniques they plan to use such as recommending hand testing instead of a backhoe. Then we receive the fieldwork schedule and make plans to participate.

There are usually several projects going on at once in the region so it's impossible to be at each one every day without more staffing, but we try to make a judgment call

and get to as many as possible.

Being on site gives you a much better sense of the landscape instead of the mapping alone. It allows you to walk the land and look for above-ground features that might be of interest in addition to the below-ground artifacts. It gives you the chance to put tobacco down and be respectful of the ancestors' lives that are being awoken on the site.

We can also discuss more in depth with the field crew about what they are finding and let them know our interests. Sometimes, we can learn from their knowledge of the geology and think about trade routes our ancestors must have traveled based on the materials used in the tools and artifacts.

Other times, archeologists will express that they have worked their whole career without interacting with the living people whose ancestors made the tools that they are digging up. In this way, site monitoring can be a chance for some degree of cultural exchange and learning.

Through being in the field and seeing for ourselves, we are another layer in ensuring that on a practical level that what was agreed to for a project is being done, and on a larger level it is a



way to do our best to honor and protect our ancestors' ways of life.

A good day for me as a tribal monitor is when I'm in a site and no materials are found. From the archeologists' perspective, they may wish to have found materials for what they contribute to science or the interest and challenge that finding the materials bring. Although, as always, it is not up to any of us and ultimately the ancestors will determine that what is being found is what is meant to be found and the rest is kept hidden.

Archeology is a fascinating field that is hopefully evolving all the time from its past to be more inclusive of Native peoples as essential collaborators and sources of knowledge about your own history.

Having a tribal archeologist would be a huge asset. For any young people in the community who might be interested, signing up for Historic Preservation's upcoming Delaware Water Gap Youth Camp this July would be the perfect opportunity. There, you can work side by side with National Parks Service and other archeologists and see for yourself what you think about it and how your work could benefit communities.

Tigerton Business Start-up Receives Shawano County Revolving Loan Fund Loan and SCEPI Revolving Micro-loan

SHAWANO COUNTY —Tigerton will soon have a new grocery store thanks to a lot of hard work by a local entrepreneur and financial assistance from local organizations. Dennis Heling, Chief Economic Development Officer of Shawano County Economic Progress, Inc. (SCEPI), is pleased to announce that a \$50,000 Shawano County revolving loan fund loan and a \$10,000 SCEPI revolving micro-loan have been awarded to Judi Hegewald, owner of Cedar Street Market and Discount Foods, LLC in Tigerton. Hegewald has purchased the property located at 234 Cedar Street in Tigerton and is remodeling the building to turn it in to an updated, appealing grocery store which will be a real asset to the community. Hegewald has also received \$7,500 in matching grants for façade and interior renovation through Shawano County Vision 2017.

Cedar Street Market will be a regular small-town grocery store with fresh meats, bakery, produce, and dairy along with a stable line of necessities. Closeouts and surplus products from the grocery industry will fill the shelves in three fourths to two thirds of the store. Closeouts become available because of overproduction, packaging changes, seasonal items, warehouse damage, or short date codes. Closeout grocery

items may be a national or private label brand and are discounted well below regular retail prices. The inventories will continually change because of the changing availability of products.

“Our main product line will be an ever-changing, diverse mix of perishable and non-perishable groceries,” said Hegewald. “Through establishing trade relationships with suppliers and producers in the local and surrounding areas, we expect to have a stable source of a great variety of products including dairy, bakery, snacks, frozen foods, and other necessities.” Future plans include featuring local products for sale as well as the possible addition of bulk products, an in-store deli, and fresh bakery.

Hegewald’s dream has been to open her own grocery store. She understands the importance of access to affordable quality food not only for her own family but for those throughout the community. “I’ve worked with area food pantries for over 25 years now. In my role as the president of Shawano Community Bread Basket, I have realized the importance of affordable quality food. In feeding my own family of seven children, my husband, and myself, I have discovered what a great help discount food stores are,” added Hegewald.

Hegewald has ties to Tigerton through her husband’s family. She knew the community was without a grocery store and was aware of the hardship it was for families, the elderly and disabled to get groceries. “When the store came up for sale, we looked at it, started praying, and started planning. We did that for two years before buying it because we realized what a huge project it would be and what a large investment of our money and our time.” Hegewald has been tirelessly working for many months. Her husband and children are also involved and have been helping with fixture and equipment purchasing and set-up, painting, inventory acquisition, and everything else required to bring this project to fruition. They plan to hire 12 employees.

According to Hegewald funding from the Shawano County revolving loan fund (RLF) and the SCEPI revolving micro-loan fund (RMLF) were an important part of financing the project. Shawano County RLF and SCEPI RMLF loans are often used as additional financial tools on development projects. “In development projects, clients will generally seek traditional commercial loans or use their own funds for their projects,” said Heling. “However, RLF and RMLF loans are often used in conjunction because of the lower interest rates and the savings the loans provide.”

Grant funds from Shawano County Vision 2017 helped with the cost of replacing windows,

completing exterior improvements and updating the lighting in the store. Shawano County Vision 2017 is a five-year economic development plan strategically designed to address various needs of area businesses and communities. It was initiated three years ago by Shawano County Economic Progress Inc. and the Shawano County Chamber of Commerce. to proactively tackle economic challenges including several plant closures, job losses, and lower than average per capita income. “This project is accomplishing what we like to see with Vision 2017 grant recipients. They are investing in the business district by renovating a vacant building and creating jobs. The Hegewalds are to be commended for working so hard to make this business a success,” said Nancy Smith, executive director, Shawano County Chamber of Commerce.

RLF and RMLF loan applications may be submitted by any person or business wishing to start a new business or business expansion project in Shawano County. Funds can be used for the acquisition of land, buildings, fixed equipment, construction, renovations, working capital and inventory. To be eligible for a RLF or RMLF loan, certain requirements must be met. SMHWC: We're Upgrading!

What?
We will be upgrading our current electronic health record (EHR). This upgrade is due to a federal mandate that all electronic transactions must transition to the ICD-10 code sets from the current ICD-9 code sets.

So what is ICD-10? The International Statistical Classification of Diseases and Related Health Problems, 10th Revision (ICD-10) was created by the World Health Organization to more accurately classify medical conditions in patient records.

Why?
This upgrade will produce more specific data about patients' medical conditions and replace outdated terms that aren't consistent with current medical practice.

When?
We will remain operational during this transition, but will be doing things a little differently. In order to provide the highest level of care during this process we will be decreasing the number of patients each provider will see to four per day **beginning Monday, July 20th**.

This will continue for at least two days, or until the upgrade has been integrated and operates seamlessly, at which point we will continue providing medical care as usual. Please be patient with us during this transition.


What else are we doing?
As part of our continuing efforts to increase patient accessibility, we would like to create an online patient portal. For those patients who are interested, you will be able to access your health records through a secured network with your own access ID and password.

If that's not enough to get you excited, we would also like to give our patients the option to receive appointment reminders and prescription alerts via text message. The first step in these projects will be to collect patient information. If you are interested in the patient portal and/or text message alerts please provide your e-mail address and/or cell phone number to the registration desk as you enter the health center and let us know your preferred method of communication.



STOCKBRIDGE-MUNSEE HEALTH & WELLNESS CENTER COMMUNITY HEALTH Healthy Start Program

We know as parents that your mission in life is to promote the health, education, and well-being of your children. Our goal at the Stockbridge Munsee Health and Wellness Center is to help you with your mission.



Well-child exam appointments are key in helping the doctor know you and your child and forming a reliable and trustworthy relationship. The continuity of regular physical exams is invaluable. Having a long-term history with a child or adolescent gives the doctor the awareness of the child's progress and development over time. This helps the doctor detect emerging problems.

Taking your child to doctor when they are not feeling well is simply not enough. There are key points of development that the physician is checking with each well child visit.

The well-child exam gives you the opportunity to raise general questions you have about your child's development, behavior, and general well-being. Recommended well-child appointments often coincide with recommended immunizations.

- 1 - 2 weeks – well child appointment
- 1 month – well child appointment
- 2 months – immunizations and well child appointment
- 4 months – immunizations and well child appointment
- 6 months – immunizations and well child appointment
- 12 months – immunizations and well child appointment
- 15 months – immunizations and well child appointment
- 18 months – immunizations and well child appointment
- 24 months (2 years) – well child appointment
- 30 months – well child appointment
- 36 months (3 years) – well child
- 48 months (4 years) – immunizations and well child appointment
- Yearly after 48 months (4 years)

The goal of giving immunizations on a set schedule is to protect your baby as soon as it is safe and effective to do so. Many doctors, scientists, and researchers work together with the Center for Disease Control to decide what is the best timing to give shots. Delaying immunizations is like playing Russian roulette with your child's health leaving them unprotected at a time when they are most vulnerable.

NOTICE TO ALL FIRST AND SECOND GENERATION DESCENDANTS WHO ARE ELIGIBLE FOR PURCHASE/REFERRED CARE SERVICES formally CONTRACT HEALTH SERVICES

At this time, we must inform all Second Generation Descendants that as of July 1, 2015 you will not be eligible for Purchase Referred Care Services for the remainder of the 2015 Fiscal Year.

As we have announced in the past, PRC funds, which are federal funds used to pay for medical services that cannot be provided at the Stockbridge-Munsee Health & Wellness Center, are limited. PRC funds usually deplete and we then switch to Tribally Funded Referral Service funds.

Second Generation Descendants are not eligible for payment using Tribally Funded Referral Services.

First Generation Descendants will continue to be eligible for services if they have been identified as being a Priority I service, which means in danger of losing your life, limbs or sight.

Payments for authorized referrals for dates of service prior to July 1, 2015 will still be covered by PRC, only if the services were authorized for payment prior.

If you receive bills after July 1, 2015 and if they are for services prior to July 1, 2015 they will still be eligible for payment by Contract Health, if they have been authorized for payment.

Please make sure to submit ALL your bills to the PRC staff at the SMHWC for review.




