**Health Director Provides Covid Update**

Andrew Miller, Health Director of the Stockbridge Munsee Health and Wellness Center (SMHWC) provided us with the information below. Here are the COVID-19 testing statistics completed at the SMHWC through today, 10/01/2021.

Total tested = 6,790 (+127 since last reporting period)  
 Total Negative Counts = 6,414  
 Total pending = 4  
 Total Positive Cases = 372 +10 since last reporting period  
 Total Positive Cases who live in Shawano or Menominee counties = 339  
 Total breakthroughs = 18 tested at the clinic to date.  
 In addition to clinic testing, we are aware of 8 additional breakthroughs in our community.  
 Total ever hospitalized = 19  
 Active cases = 18  
 Recovered Cases = 351  
 Deaths (tested at clinic) = 3  
 Total deaths = 4

Miller Stated "On average 8.2% of tests conducted by the clinic over the last 7 days were positive. This rate is slightly larger than

Wisconsin's 7 day average percent positive of 8.0%. In addition to testing conducted at the Clinic, there were 3 positives reported from National Guard testing this week."

Of the 13 Positives (10 from the clinic, 3 NG)  
 4 Breakthroughs (Vaccinated 12 years and Older)  
 9 Unvaccinated  
 2 Unvaccinated (Under 12 yrs old)  
 7 Unvaccinated (12 years or older)

Miller continues in saying Shawano County had 236 new cases in the last 7 days and continues to experience a high rate in covid-19 transmissions <https://covid.cdc.gov/covid-data-tracker/#county-view> Please consider getting a vaccine to help protect yourself and those who cannot get the vaccine. 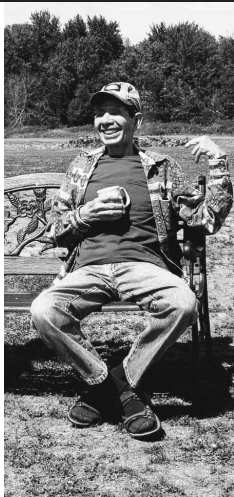

The average box will be 14-16 pounds and will contain a combination of protein and produce. The contents of the boxes will change for each distribution based on what is available seasonally for the given distribution week.

The number show that 5,549 doses of Covid-19 vaccine have been administered by the Tribe as of 10/01/2021. The count of fully vaccinated people is 2,669.

Count of people who received both doses of vaccination (Pfizer or Moderna): 2,567

Count of people who received first dose of vaccination and are awaiting 2nd dose (Pfizer or Moderna): 228

Count of people who received a 3<sup>rd</sup>/ booster dose (Pfizer or Moderna) 85

Count of people who received single dose (Johnson & Johnson): 102

### 3<sup>rd</sup> Booster Shot of Pfizer

CDC along with FDA approved a 3<sup>rd</sup> (booster) shot of Pfizer Covid-19 vaccine for those people who:

- 1) received 2 doses of Pfizer *and*
- 2) received the 2<sup>nd</sup> dose at least 6 month ago *and*
- 3) meet one of the criteria items below:

- people 65 years and older and residents in long-term care settings **should** receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine

at least 6 months after their Pfizer-BioNTech primary series,

- people aged 50–64 years with underlying medical conditions **should** receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series,
- people aged 18–49 years with underlying medical conditions **may** receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks, and

- people aged 18-64 years who are at increased risk for COVID-19 exposure and transmission because of occupational or institutional setting **may** receive a booster shot of Pfizer-BioNTech's COVID-19 vaccine at least 6 months after their Pfizer-BioNTech primary series, based on their individual benefits and risks.

## Facts About Falls

Per CDC fall death rates in the US increased by 30% from 2007 to 2016

Each year, millions of older people--those 65 and older--fall. In fact, more than 1 out of 4 older people fall each year, but less than half tell their doctor. Falling once doubles your chances of falling again.

### Falls can be serious and costly

- Falls are the most common cause of traumatic brain injury (TBI)
- More than 95% of hip fractures are caused by falling, usually by falling sideways
- 1 out of 5 falls causes serious injury such as broken bones or a head injury

### What can make you more likely to fall?

- ✓ Lower body weakness
- ✓ Medication side effects
- ✓ Vision problems
- ✓ Foot pain/soreness and poor footwear
- ✓ Home hazards (ex: throw rugs, uneven/broken steps, clutter can be tripped over)

### Side effects of a fall

- ✓ After a fall, even if no injuries occur, many people may become fearful of falling and decrease their daily activities. When a person is less active, they become weaker and this increases their chances of falling
- ✓ May have broken bones or may cause a head injury

### What are some things you can do to help prevent a fall?

- ✓ Talk to your doctor
- ✓ Do strength or balance exercises
- ✓ Have your eyes checked
- ✓ Make your home safer

## Important reminder



According to Stockbridge Munsee tribal ordinances - Chapter 56 Food Service Code – all vendors selling food on the Stockbridge Munsee reservation must comply with our food code.

Chapter 56.2 speaks specifically to the point of obtaining Food Service Permits. Food Service Permits are **mandatory** for food service operation.

- Food Service Permits will not be issued unless the vendors comply with all aspects of our food code.
- Our Food Code requires all food handlers to have documentation of a current FOOD HANDLER CARD and food stands must submit to inspection prior to any sales.

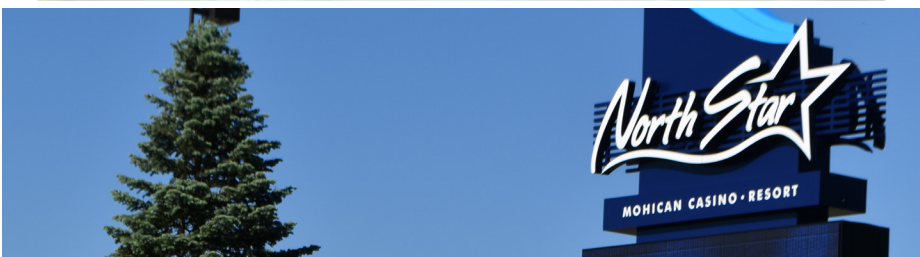

### Think Smart Before You Start: ATV/UTV Safety Saves Lives

**MADISON, Wis.** –

When enjoying off-road rides and adventures, wearing a helmet and seat belt, monitoring speed and using caution on hills and uneven terrain could save your life.

So far this year, 26 people have died in ATV/UTV crashes. [Most crash victims were not wearing seat belts or helmets.](#)

"As we enjoy those late-summer rides and get ready for fall excursions, it's important to use caution and wear protective gear," said Lt. Martin R. Stone, DNR Off-Highway Vehicle Administrator. "Rollover crashes have caused nearly half of the ATV/UTV fatalities in Wisconsin in 2021. Monitoring speed and using caution on rough terrain is critical; some terrain in Wisconsin is too steep for ATVs and UTVs."

Follow these tips for a safe ride:

- Never consume alcohol or drugs before or during your ride.
- Wear a seat belt and a Department of Transportation (DOT)-approved helmet.
- In addition to a seat belt and helmet, wear protective clothing, eye protection, gloves, long pants and a long-sleeved shirt.

- Keep your speed in check for the terrain, visibility conditions and your experience.
- Remember that some terrain in Wisconsin is too steep for ATV/UTVs. Please be careful while traversing hills or uneven terrain.
- Know before you go.

One of the best things ATV and UTV operators can do to operate safely is to take an online safety course. [A list of approved safety education classes is available on the DNR Safety Education webpage.](#)

ATV and UTV operators born on or after Jan. 1, 1988, who are at least 12 years old for an ATV (and at least 16 years old for UTV) must complete an ATV safety certification course to operate in Wisconsin (exception: on private property owned by operator's immediate family).

Wisconsin law requires every operator involved in a crash incident to report the incident without delay to law enforcement officials. In addition, within 10 days of the incident, the operator must submit a [written report to the DNR](#). For more info on ATV and UTV rec in Wi, [visit the DNR's website.](#)

## Influenza (Flu) Vaccines are here!

Fellow Stockbridge Munsee tribal members, due the state of the Covid-19 Pandemic Community Health will not be having a regular “flu clinic” days. You are welcome to schedule an individual appointment at the clinic or the Community Health nurses can come to your home and provide the immunization there. We are encouraging everyone to get the flu vaccine, it is more important again this year because of the Covid-19 respiratory virus.

If you are not normally seen by a Community Health Nurse and are a patient of the Stockbridge Munsee Health and Wellness Center, we can still come out and give you the immunization. Call 715-793-5060 and we will schedule a time to come to your home. **Protect yourself, your family and your community – get the flu shot!**

- Flu Vaccine is the best protection against the flu  
You can not get the “flu” from an influenza vaccine; the vaccine is created with a dead virus. The dead virus can not replicate and give you the flu. Instead the dead virus “tricks” your body in to thinking it has been infected and builds up your immunity. That is why some people may feel a little uncomfortable and think they got the flu after immunization. The next time your immune system is exposed to that flu virus, it has already built up protection against it.
- Elders and people with chronic health conditions can develop more serious complications from the flu.  
Almost everyone over 6 months of age should get a flu vaccine. As we age our immune system slows down too and doesn’t react as effectively as it did when we were younger. Chronic health issues such as diabetes, kidney disease, asthma, heart disease and stroke make influenza a much more serious illness.
- Flu vaccines are given in the Fall to provide the best protection during “peak” flu season.  
We usually see flu season peak during the winter months, but we have had both early and late flu seasons.
