We would like to take the opportunity to inform you the Stockbridge-Munsee Community has created an Aging & Disability Services Program which includes Elderly Services, Ella Besaw Center, Medical Transportation, and a Tribal Family Social Worker. Our brochure provides a brief description of our many community-based services. We strive to provide efficient and effective services to all community elders and disabled community members.

The Medical Transportation Department is available to provide rides to and from medical appointments for Enrolled Community members and their family. We have one WHEELCHAIR capable vehicle and two other vehicles. This service is provided in its entirety by the Stockbridge-Munsee Tribe. We ask that you please call one week or more in advance. Call us at 715-793-5040.

The Ella Besaw Center is an eight-bed class CSA Community Based Residence Facility (CBRF), owned and operated by the Stockbridge-Munsee Tribe since May of 1991. The Center employs a new concept in supportive care for Elders and physically handicapped persons who cannot or choose not to live alone. The purpose is to retain and enhance independence and quality of life...

There have been several questions volleved in our community about the need for more of any and all of the following: treatment alternatives, treatment services, wrap around services, trauma knowledge-based community resources, awareness prevention sources, ways for community members to serve and help and provide and nurture, and mentor those who are in the grip of addiction to substances. The desperate cries of folks who are growing weary and tired of seeing the damage that substances can cause for so many families and extended loved ones.

Shaaxkooxweewaakan – the healing path - a diversionary treatment-based healing wellness program - is beginning to form and gaining strength to be fully operational. Shaaxkooxweewaakan substantiated resources and a deep commitment to assist. It is not just treatment. It is not just "another short-term program that intends to follow through with only a short amount of time, with just short-term results. Tribal Council Mandates Vaccinations for All Employees

The Stockbridge Munsee Tribal Council adopted a COVID-19 vaccination mandate that applies to all tribal employees on November 16, 2021. Like many other employers and recent guidance issued through the federal government, the Tribal Council believes implementation of this vaccination mandate is necessary to help our community, state, and nation move forward to normal operations again.

While the Tribal Council believes this mandate is necessary, it does not take this step lightly. We recognize many employees have had strong feelings on this issue. However, the Tribe has taken a strong proactive approach on employee and community safety during the COVID-19 pandemic, and we feel this mandate is the necessary next step.

Employees will be required to provide proof of complete vaccination by January 4, 2022, to remain employed (receiving both shots in the 2-shot series or receiving the 1-shot vaccination). Employees who fail to comply will be treated as voluntary separations from employment. If you have already provided proof of vaccination as part of requesting vaccine incentive, additional proof is required at this time. A copy of the Tribe's updated COVID-19 safety program with the vaccination requirements for employees is enclosed.

Employees may request an exemption from the vaccination mandate based on medical or religious reasons. Forms to request an exemption and accommodation will be made available. These

Compost Program Awarded Recycling **Excellence Award**

No one will argue that 2020 was one of the most difficult years to coordinate and execute any type of program and see successful results. The global pandemic shut down/limited what could be accomplished throughout the year. Despite two government shutdowns and limited restaurant menus, hours and staffing, the Stockbridge-Munsee Community (SMC) Compost Program was recently awarded the Recycling

Excellence Award for Projects or Initiatives from the Department of Natural Resources (DNR) for its superior performance last year.

program is designed to encourage and reward communities and programs for outstanding efforts, performance innovation and in recycling or diversion while providing examples for others" (DNR). Awards are offered in four categories: Projects and Initiatives, Overall Program, Innovation, and Special Events. The Projects and

"The Recycling Excellence Awards

Initiatives award "recognizes a defined project or initiative that increases materials recycled or diverted, and/or improves the cost-effectiveness of a recycling/ diversion program" (DNR).

Since the beginning of the SMC Compost Program in 2017, a total of 31,811 lbs of food waste from the casino kitchen has been turned into compost. This year, 7,429 lbs of food waste was turned into compost, equating to a little over 1,000 lbs per month. The compost is then used in the gardens at From the Earth Farm to help grow the wide-range of produce we all enjoy.

Earlier this year, the SMC Compost

Program was highlighted nationally through the Growing Compost to Grow Your Food System -Virtual Course put on by the Institute for Tribal Environmental Professionals (ITEP). Throughout the two-day virtual course, we helped educate other tribes and individuals throughout the country, looking to start a compost program of their own or enhance their current program, on how composting works and how our program operates.

The Environmental Department would like to thank everyone who has helped make our compost program a huge success and we look forward to what the future holds for our program.

Shaaxkooxweewaakan is a diversionary program for sobriety. It is justice reform.

It is essentially a very unique collaboration of agencies that do not normally interact. Some will be referred to the program through a citied ordinance issue, others will receive a referral due to a violation on their record, which can be erased upon graduation of the program. And still others can be referred due to having drug substance issues in their home that is causing possible harm for minors and other family members who are residing with them.

Each team member of the Shaaxkooxweewaakan program is working from their perspective but combining talents to support a program participant each step of the way through the duration of the entire program until they reach graduation / transition. It is entities striving for the best answers of sobriety ways for the participant. It is a well-oiled machine. Each team member provides feedback to the presiding Judge who makes the decisions for the program. The purpose is to provide a comprehensive individualized program that looks at the other factors that influence substance use and abuse. Providing judicially supervised substance abuse treatment options that are fitting to that may be more fitting to the person's life, as well as their family and ultimately a very positive ripple into the community in which they live. Shaaxkooxweewaakan can make available transitional and aftercare options to see that person needing aftercare or transitional assistance can successfully reenter life in their community. One major positive piece for a participant is the oneon-one assistance that we will provide to them and their needs. That is the ingredient which makes this program much more just than a committee of members or a work group dealing with prevention tactics is the one-on-one care that is provided for each participant, the guaranteed random drug screening, and incentives and even sanctions all provided under intense supervision.

The healing to Wellness model is an adaption that incorporates the nationally ran drug court model (that by years of national research is proven to be of huge success when managed to be progressive and sustained) with the culture tradition, and people of a tribal community. The healing to wellness Tribal model has been gaining strength in the past 2 decades. In Wisconsin, Menominee, Forest County Potawatomi, Lac Du Flambeau, and Ho Chunk tribes began tackling drug issues and

assistance to those dealing with addictions by developing their own healing to wellness courts. This last year has also shown the pending debut of healing to wellness programming within the Oneida Tribal Nation, La Courtes Oreilles, and here at the Stockbridge Munsee. With staff turnover and management differences and desires; programs that are selfsustaining and progressive have weathered the storm of funding issues and massive staff shortfalls, turnovers, and staff shortages. County Currently, Forest Potawatomi and Ho Chunk tribes are the longest running and still active programs within the tribal nations of Wisconsin.

What is the day to day duties of the healing and wellness court?

Ona daily basis, I as the Coordinator will be either meeting participants, contacting outside reservation entities and organizations who are branches of serv ice to our participants, setting up those services, support the billing and appropriated funding for the program and its activities, retrieving progress reports, meeting with new referrals, performing participant intake tasks, setting up the team schedule and facilitating Shaaxkooxweewaakan programming, Mediating staffings and team sessions, working directly with each team member verifying and participant progress, working to establish a court appearance for each participant collecting their weekly report, analyzing their progress through the phases of the program, facilitating life skill sessions, mentor meetings, Shaaxkooxweewaakan into the community through various education awareness campaigns, coordinating treatment options for each participant, drafting reports for the size and scope of our program, being called to manage and oversee a mandated by court drug screen, performing public relations in all aspects of promoting wellness and the healing to wellness court program.

Also, to note, it is also important to realize that the system of the program needs to stay fluid enough that it can withstand changes that take place — changing faces of presiding team, pressing community issues that may be connected to drug use and substance problems, the ability to reevaluate on a yearly basis to adapt to needed mandatory changes and necessities.

What kind of plans do you/Wellness Court have for the community?

Originally when the idea was conceived of taking on the project of a healing to wellness court based program, it was envisioning

the lengthy process it would require for the program itself to gain a foothold in the community, create its foundation of necessary agreements, drafting an accepted Tribal wide ordinance that gave birthright and full comprehensive definition to the program, hosting critical conversations with entities who would serve as instrumental team members for the program. provide overview training and facilitate the team to convene and further provide structure of the processes needed to make referrals and court sessions and each of the other intricate pieces a solid working machine through teamwork. This in itself can be a very lengthy operation. But, due to the visible need that has risen within the community, the tribal Legislature has noted the urgency and are in full support to seeing the Shaaxkooxweewaakan program taker its first breaths in the community and begin to see referrals coming our way as possible first participants.

This also included an extended vision which also would allow for sister programs and court program s that could evolve and piggyback off of Shaaxkooxweewaakan efforts and successes such as Veterans court, DWI courts, Family drug / mediation court, Co Occurring issues programming, Youth in Governance / Peer to Peer court program.

What can the community do to help you/Wellness Court?

There are several things that community members can do. In the months ahead, Shaaxkooxweewaakan will be initiating public forums and live Facebook discussions pertaining to the issues surrounding drug abuse and substance use within the community. These public forum type panel discussions will involve professionals sharing their expertise, as well as community Elders who have dealt with the struggle of substance abuse. The

purpose is to bring about a clear awareness of the drug issues that people face.

I also ask everyone to think strongly of being a willing active participant in the discussions and become part of the Shaaxkooxweewaakan Facebook page for wellness. Actively find ways to increase your learning about the substances, as knowledge is certainly powerful. Neighborhoods can neighborhood watch programs. 100 percent awareness is the effect of being vigilant and watchful for community children and youth and families. Do not hesitate to call authorities if someone needs help. And most importantly, if there is a family member who is dealing with substance issues, do not hesitate to contact the Shaaxkooxweewaakan program located within the Tribal Court.

One final capstone thought from not only myself, but the entire tribal Court team, that is best stated by our Chief Justice Higgins "we are here to help, we want to see complete healing and wellness for individuals and their families, we will do whatever we can to aide in healing of our people and the community."

Student Loan Debt Relief Scammers Target Worried Borrowers

MADISON, Wis. — The final extension of the federal student loan payment pause runs until Jan. 31, 2022. The Wisconsin Department of Financial Institutions (DFI) and the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) encourage student loan borrowers to be cautious of offers from questionable student loan debt relief companies, to be aware of fraudsters taking advantage of this transition period, and to create a repayment plan now before their student loan payments are due.

"Student loan debt relief scammers target borrowers with false offers of loan forgiveness or savings from consolidation," said DATCP Secretary Randy Romanski. "There are many resources consumers can access without paying a fee. I encourage borrowers to utilize the resources at DFI for information about repayment services and report any fraud to our team at DATCP."

"With student loan payments resuming in February 2022, it is more important than ever for borrowers to explore their student loan repayment options and make a plan for repayment today," said DFI Secretary Kathy Blumenfeld. "Borrowers should take time now while payments are still paused to look into repayment options such as income-driven repayment plans, which lower monthly payments, and check their eligibility for student loan forgiveness. Not waiting until the last minute to make a plan is important and will help ensure a smooth return to repayment."

Student loan borrowers should be wary of phone calls, emails, letters, and texts claiming relief from federal student loans or warning that student loan forgiveness programs are immediately expiring. These aggressive solicitations are used to scam borrowers with fees for services that are often free, and can be used by fraudsters to steal their money and identity.

Signs of a fraudulent student loan debt relief company:

- Up-front fees These types of fees are prohibited for loan service providers. Do not provide credit card numbers or bank account information.
- Promises of immediate total

loan forgiveness – Most government forgiveness programs require many years of qualifying payments and/or employment in certain fields before loans can be forgiven.

- Requests for a borrower's FSA ID username and password A borrower's FSA ID has the same legal status as a signature, it can be used to make changes to the borrower's account without their knowledge. Do not share a borrower's FSA ID.
- High-pressure sales phrases

 Fraudulent student loan debt relief companies often try to instill a sense of urgency by citing "new laws" or "discontinuing programs" as a way to encourage borrowers to contact them immediately.
- Requests for a third-party authorization form or power of attorney Debt relief scammers often want these authorizations to change the borrower's contact information so they won't be notified when the loan servicer stops paying the student loan bill.
- Spelling or grammatical errors – Communications with misspelled words or grammatical errors often indicate the communication is likely from a scammer and should be deleted.

Student loan borrowers can find free repayment resources on DFI's LookForwardWI.gov website, including the Wisconsin Strong Student Loan Repayment Tool provided by the student loan experts at Savi. This tool helps student loan borrowers navigate the complexities of federal student loan repayment plans, forgiveness programs, and lowering student loan payments. requests will be evaluated by HR for eligibility. Medical exemptions must be consistent with CDC guidance on contraindications and precautions. Religious exemptions must be for a sincerely held religious belief where a tenet of the religion conflicts with vaccination.

Please be aware, even if an employee is eligible for an exemption, it does not mean an accommodation can be made. The safety of all employees, patrons and the public must be considered along with the ability to apply an adequate safety program that includes weekly testing. These requirements will likely create an undue hardship that precludes an accommodation being possible. Therefore, even if you are granted an exemption, continued employment might not be possible. Matters of public health necessitate difficult choices for the greater good of our community.

The Tribal Council continues to appreciate all that our employees

do for our community. We feel this approach is the best path forward now given local infections rates, employment trends, and especially since this approach will be mandated nationally.

and to preserve family and Community ties. We offer a setting that is as much like "HOME" as possible...a place to feel secure in knowing that someone who cares is nearby. It is a place to share with others and still maintain privacy. For more information, including room availability, call Erin AT 715-793-4530.

The **Trial Family Social Worker** is a new position that has been created to provide services based on individual needs, assessment, and plan.

The Stockbridge-Munsee Community also provides home based services to assist our Elderly and Handicapped Tribal members. Below is the Policy Listed for Lawn/Snow Care received from the Elderly Services Department.

To assist in determining who may be eligible for basic lawn care and snow removal services for Elders and Disabled persons by the Tribe. The services provided by the Tribe and this policy are meant to be a supplemental service to help with lawn care/snow removal and to ease the burden on our elders/disabled persons. This service is NOT designed to be the elder/disabled persons only source of lawn care/snow removal. Services are dependent on staff, equipment, resources, nature, etc.

To be Eligible for Elderly Services you must:

- 1. Stockbridge-Munsee enrolled elders aged 62 years and older
- 2. Stockbridge-Munsee enrolled disabled person
- 3. Surviving spouse of Stockbridge-Munsee enrolled member and 62 years of age and older.

In order to manage both services the following will be required

- 1. All persons must complete and sign an authorization form
- a. Authorization forms can be obtained at the Housing Office or on-line at Mohican.com.
- 2. Disabled persons must provide proof of disability and attach it to the Authorization Form. Acceptable proof: verification of disability status from Social Security Administration, verification from two medical providers, or verification from any Federal, State or County programs that recognize you as disabled to qualify for their program.
- 3. Surviving spouse of enrolled member must be age 62 and provide the name of deceased Service Area:

The 1856 Treaty Boundaries of the Stockbridge-Munsee Community Reservation which includes the two Townships of Bartelme and Red Springs and will also include the Villages of Gresham and Bowler, WI.

Services:

By signing the Authorization for Lawn Care/Snow Removal

Form you acknowledge that by requesting these services, you accept the inherent risks from these activities. The Tribe is not responsible for any damages caused to vehicles, homes, windows, or any items on lawns due to mowing or flying debris resulting from mowing/weed eating and/or damages

Residency:

The eligible participants primary residence MUST be the address they provide on the authorization. Questions of residency may require verification by providing a copy of a Tribal Council approved lifelong lease, current lease, property tax info or land assignment. A person may only receive services at one address.

- 1. Lawn Care: mowing and weed eating
- a. Mowing of lawn will be a maximum of 100 feet around the perimeter of the home, no expansions will be allowed. If your yard is smaller, you will only get the area you have. If your yard is larger, you will only get the 100 feet around the perimeter of home. b. Lawn area grass must be less than 8 inches long.
- c. Lawn must be cleared of all objects that prevent the lawn from being properly and safely mowed without causing damage to property: toys, bicycles, garbage, large rocks, brush, lawn ornaments that are moveable, dog feces, etc. A lawn may NOT be mowed if these conditions are present.
- d. Lawn Care services are NOT provided to anyone under the age of 62 years of age unless person is disabled.
- 2. Snow Removal: plowing and shoveling
- a. Snow removal will only occur after 3 inches or more of snow has fallen.
- b. Plowing will be completed on the driveway only
- c. Gravel driveways will NOT be plowed if the ground is not completely frozen in order to protect damage to the driveway and equipment.
- d. Shoveling of main entrance will be done at time of plowing if needed.
- e. Driveways, entrances and walkways must be cleared of personal items/objects that could be damaged. This includes any area that snow may be pushed, piled, etc. with snow.




